GOODS	DOCUMENTS REQUIRED	CUSTOMS PRESCRIPTIONS	REMARKS
Personal effects	<ul> <li>Copy of valid passport</li> <li>Copy of valued inventory in French, dated and signed by the shipper</li> <li>Dated and signed copy of the Washington Convention</li> <li>Invoice for all electrical appliances less than 6 months old</li> <li>Resident/work permit or letter from the employer explaining that the client is starting a new contract in Chad</li> <li>Non-sale certificate (declaration that the client will not sell his personal effects in Chad)</li> <li>Copy of agreement with the Government for NGO employees</li> <li>Change of residence certificate from the city hall of the current city of residence or from the expatriates.</li> </ul>	<ul> <li>All documents must be provided to removal company in Chad, 4 days before the arrival of the shipment, in order to apply for and be granted duty-free clearance.</li> <li>Non-exempt shipments will be subject to a 2% "Statistical Tax", based on the CIF inventory value.</li> <li>Household goods shipments without exemption or that don't have a change of residence certificate are subject to 70% customs tax, based on the CIF inventory value.</li> </ul>	<ul> <li>Please note that all imports are opened and checked by customs.</li> <li>Caution: the certificate of removal is compulsory, including for diplomats and NGO members. If this document is not provided, the effects will be taxed (70%).</li> </ul>
Motor vehicles	<ul> <li>Original car registration</li> <li>Insurance certificate</li> <li>Original purchase invoice</li> <li>Non-sale certificate</li> </ul>	<ul> <li>Taxes on motor vehicles will depend on age, engine, etc. (approximately 61% of CIF value).</li> </ul>	<ul> <li>You must provide official documentation showing the engine number and engine capacity, car registration document or registration certificate.</li> </ul>
Prohibited items		<ul> <li>Firearms and ammunitions are submitted to authorisation from the regional administration</li> <li>Drugs</li> </ul>
